



COOPERATION AGREEMENT BETWEEN THE MUNICIPALITY OF WINTERSWIJK AND THE BERYSLAV URBAN TERRITORIAL COMMUNITY

Party 1 Municipality of Winterswijk, located at Stationsstraat 25, 7101 GH Winterswijk, the Netherlands, represented by and through Joris Bengevoord, and

Party 2 Berislav urban territorial community, located at: 244 Heroes of Ukraine Str., Beryslav, Beryslav rayon, Kherson oblast, represented by Oleksandr Alchiev, head of Beryslav City Military Administration the village head have concluded this Memorandum of Cooperation (hereinafter referred to as the Memorandum)

SUBJECT OF THE AGREEMENT

The Parties agree to develop economic, cultural and tourism cooperation, to strengthen friendly relations.

AREAS OF THE AGREEMENT

Areas of cooperation: economy, tourism, municipal services, energy, education, culture, social sphere.

OBLIGATIONS OF THE PARTIES

The Parties undertake to create favourable conditions through the cooperation of local authorities:

1. Development of joint projects and exchange of best practices in the areas covered by the Agreement;
2. Organization of joint events and work meetings;
3. Exchange of delegations of relevant municipalities, non-governmental organizations and business people;
4. Development of friendly ties between citizens of two municipalities, in particular between delegations in the field of art and culture, as well as exchange of pupils, students, athletes and other delegations;
5. Exchange of information about the history and life of communities (for example, photographs, audiovisual materials) and promotion in local mass media;
6. Support at international competitions;
7. Cooperation in the framework of city-wide events; festivals; competitions, etc.

VALIDITY OF THE AGREEMENT

This Agreement shall become effective on the date of its signature by both Parties. The Agreement is for an unlimited period.

The Parties may from time to time, by mutual agreement, modify the areas of further cooperation, the terms of the Agreement, etc.

The Agreement may be terminated at any time by either Party by written notification to the other Party or by common agreement of both Parties.

In the event of disputes and differences of interpretation, the Parties shall use their best efforts to resolve them by negotiation.

The Agreement is concluded in two originals, in Ukrainian and English languages. Texts in all languages have the same validity.

Both Parties have read the Agreement and signed it freely. Both parties represent that the persons signing this Agreement are authorized to do so by the Party on whose behalf they are signing.




